**Sub: Modification of Form CST I**


Whereas, vide Finance Department Notification No. No.30653-FIN-CT1-TAX-0022/2020 dated 05.11.2021 the tax rate on Motor Spirit (Petrol) and HSD has been reduced to 28% and 24% respectively with effect from 06.11.2021;

And whereas, the aforesaid change in tax rate warrants minor modification of Form CST I prescribed under Rule 34(1) of CST (O) Rules, 1957.

Now, therefore, in exercise of the powers conferred under sub-rule (4) of rule 7 of CST (O) Rules, 1957, I, Sushil Kumar Lohani, IAS, Commissioner of Sales Tax, Odisha, Cuttack, do hereby make the following modifications in Form CST I with effect from 06.11.2021.




