NOTIFICATION

In exercise of the powers conferred by Section 5 of the Orissa Value Added Tax Act, 2004 (Orissa Act 4 of 2005), in supercession of earlier Notification No.11544/CT dt.17.07.08 and Notification No. 11550/CT dt. 17.07.08, I, Sri T.K. Pandey, I.A.S., Commissioner of Sales Tax, Orissa, do hereby delegate the powers and duties to be exercised by the Officers appointed under sub-section (2) of section 3, to the extent as specified in column (2), column (3), and column (4) of the schedule below, within their respective areas of jurisdiction. 
