NOTIFICATION

In exercise of the powers conferred by Section 15A of the Orissa Entry Tax Act, 1999, as amended by Orissa Act 10 of 2005, in supercession of earlier Notification No.13414/CT dt.16.08.07 and Notification No. 19070/CT dt. 15.12.07, I, Sri N.B. Dhal, I.A.S., Commissioner of Sales Tax, Orissa, do hereby delegate the powers and duties to be exercised by the Officers appointed under sub-section (1) of section 15, to the extent as specified in column (2), column (3), and column (4) of the schedule below, within their respective areas of jurisdiction. This has been approved by Government in Finance Department vide letter No.3940/F. dated-30/01/2010 and letter no. 9166/F dated-26/02/10, as required under sub-rule (2) of rule 29 of the Orissa Entry Tax Rules, 1999.
