

STEP-BY-STEP GUIDE TO VERIFY THE REGISTRATION / ENROLMENT UNDER PROFESSIONAL TAX FROM THE PORTAL OF CT & GST ORGANISATION, ODISHA

After registration is granted to an Applicant under the Odisha State Tax on Professions, Trades, Callings and Employments Act 2000, a TIN consisting of 11 digits is issued to the Applicant. Using the TIN of a registered dealer, the status of registration can be verified from the Portal of CT & GST Organisation, Odisha.

1. Please go to <https://odishatax.gov.in> and click on the link “Dealer Search” as shown below.

3. Please enter the TIN or the name of the dealer in the appropriate text box and click on Search to have the details displayed. A screenshot is given below.

4. The status of registration under various State Acts will be shown in the information displayed. As can be seen, there will be a legend “R” shown against PT Enrolment, which implies that the dealer is registered under Professional Tax Act and the date of effect will also be shown.

5. By clicking on the “R”, it will further open another window showing details of the dealer, as can be seen from the screenshot below.
