**NOTIFICATION**

Sub: Modification of Form VAT-201A


Whereas, vide Finance Department Notification No. No.15383 -FIN-CT1-TAX-0022/2020 dated 16.05.2020 the tax rate on Motor Spirit (Petrol) and HSD has been enhanced to 32% and 28% respectively from 17.05.2020;

And whereas, the aforesaid change in tax rate warrants minor modification of Form VAT-201A prescribed under Rule 34(1) of Odisha Valued Added Tax Rules, 2005.

Now, therefore, in exercise of the powers conferred under sub-rule (13) of rule 34 of Odisha Value Added Tax Rules, 2005, I, Sri Sushil Kumar Lohani, IAS, Commissioner of Sales Tax, Odisha, Cuttack, do hereby make the following modifications in Form VAT-201A-


In Form VAT-201A, for row 39, 40, 41 and 42, the following shall be substituted, namely-


