ORDER

Consequent upon the Notification of the Government in Finance Department in FIN-OFS2-CADRE-0001/2017-2410 / F dated 29.01.2018, Sri Bhuban Mohan Behera, OFS, ex-Joint Commissioner of Commercial Tax (Appeal), Cuttack II Range, Cuttack has been promoted and posted as Additional Commissioner of Commercial Taxes (Appeal) (Central Zone), Cuttack. So the post of Joint Commissioner of Commercial Taxes (Appeal), Cuttack II Range has fallen vacant. In the absence of the JCCT (Appeal), the 1st appeal cases of Cuttack II Range, which were being adjudicated by Sri Behera, will remain unattended. Therefore, for timely disposal of the pending 1st appeal cases of Cuttack II Range, Cuttack, the following is hereby ordered:

- (A) In exercise of the power vested u/s 6 of the OVAT Act, 2004, it is ordered that all 1st appeal cases, which were being adjudicated by Sri Behera as ex-Joint Commissioner of Commercial Taxes (Appeal), Cuttack II Range, are hereby transferred *in toto* to Sri Behera, now posted as Additional Commissioner of Commercial Taxes (Appeal) (Central Zone), Cuttack.
- (B) In exercise of the power vested u/s 3 of the OVAT Act, 2004 and u/s 15 of the OET Act, 1999, it is further ordered that he will continue to exercise the power of the 1st Appellate Authority of Cuttack II Range, Cuttack for the appeals filed against orders of Deputy Commissioners of Sales Tax, Assistant Commissioners of Sales Tax and the Sales Tax Officers and function accordingly.
- (C) For the sake of convenience of the stakeholders, Sri Bhuban Mohan Behera is also directed to conduct his office work in the office of Cuttack II Range, Cuttack till further order. The Joint Commissioner of Commercial Tax, Cuttack II Range, Cuttack is directed to provide all logistical and secretarial support to Sri Behera so as to enable him to discharge his official duties smoothly.

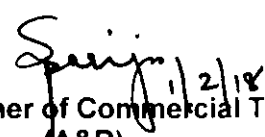

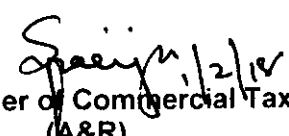
