ORDER

Consequent upon the Notifications of the Government in Finance Department vide FIN-OFS2-CADRE-0002/2017-36338/F dated 11.12.2017 and FIN-OFS2-CADRE-0001/2017-2410/F dated 29.01.2018, Sri Dilip Satpathy, ex- Joint Commissioner of Commercial Taxes, (Koraput Range, Jeypore), Sri Jayanta Kumar Das, ex-Joint Commissioner of Commercial Taxes, (Sambalpur Range), Sri Biseswar Mishra, ex-Joint Commissioner of Commercial Taxes, (Puri Range) and Sri Arun Kumar Biswal, ex-Joint Commissioner of Commercial Taxes, (Bhubaneswar Range) have been promoted and posted as Additional Commissioner of Commercial Taxes in the same Territorial Ranges respectively. Therefore:

- (A) In exercise of the power vested u/s 6 of the OVAT Act, 2004 read with Rule 34 of the OET Rules, it is hereby directed that all the appeal and revision cases under OVAT & OET Acts pending with the said officers before their promotion are hereby transferred to the same officers as Additional Commissioners of Commercial Taxes of the same Territorial Ranges respectively.
- (B) It is also hereby directed that all fresh Appeal and Revision cases of the said Territorial Ranges shall be filed before the said Additional Commissioner of Commercial Taxes who will thereafter suitably allocate the cases among the other Appellate / Revisional authorities of the Range.

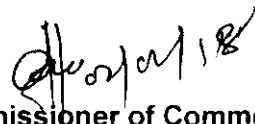

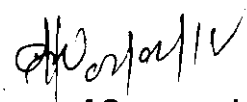

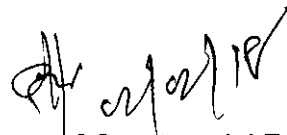
