Sub: List of dealers of Bhubaneswar-I Circle, whose tax period shall comprise a 'month'.

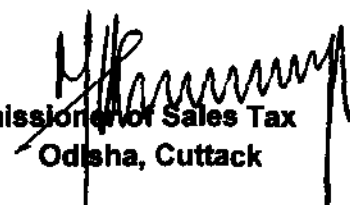

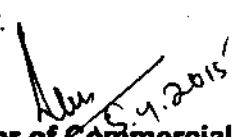
