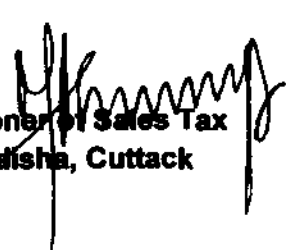
**Sub: List of dealers of Cuttack-I-East Circle, whose tax period shall comprise a 'month'.**

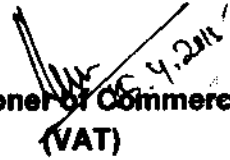

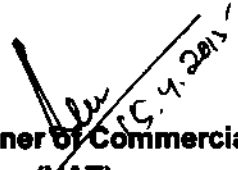
