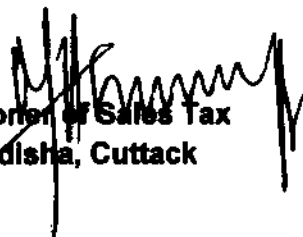
Sub: List of dealers of Cuttack-I-West Circle, whose tax period shall comprise a 'month'.
