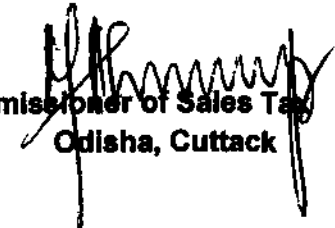
Sub: List of dealers of Jagatsinghpur Circle, whose tax period shall comprise a 'month'.

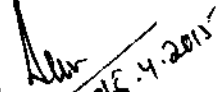

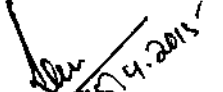

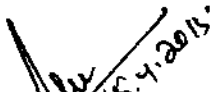
