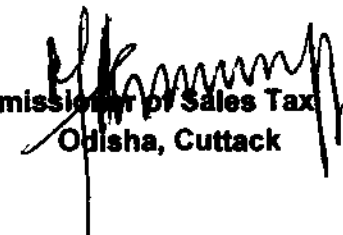
Sub: List of dealers of Jharsuguda Circle, whose tax period shall comprise a 'month'.

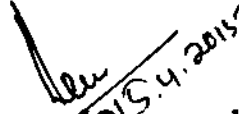
