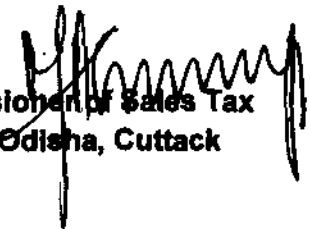
Sub: List of dealers of Kalahandi Circle, whose tax period shall comprise a 'month'.
