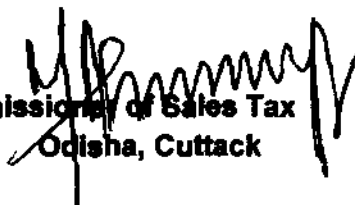
Sub: List of dealers of Nawarangpur Circle, whose tax period shall comprise a 'month'.
