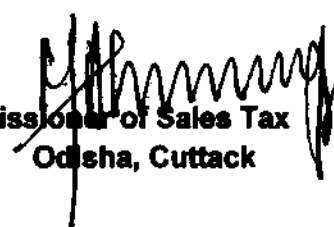
Sub: List of dealers of Rourkela-I Circle, whose tax period shall comprise a 'month'.

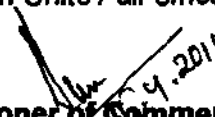
