NOTIFICATION

The 15th December, 2015

SRO No. _____ / In exercise of the powers conferred by section 6 of the Odisha Entry Tax Act, 1999 (Odisha Act 11 of 1999), the State Government, having been satisfied that it is necessary so to do in the public interest, do hereby direct that the Scheduled goods quantum to the extent of which as specified below, which would be procured into the local area by the State Pollution Control Board, Odisha to set up Continuous Ambient Air Quality Monitoring stations located at (a) Angul-Talcher Area and (b) Ib Valley Jharsuguda area shall be exempted from levy of tax under the said Act on its entry into the local area subject to condition that the State Pollution Control Board, Odisha shall furnish a copy of the certificate, in the proforma as appended to the Finance Department Office Memorandum No. 36246/F, dated the 20th October, 2012, duly signed by the authorised officer of that office to the officer in-charge of the concerned check gate and another copy of such certificate shall accompany with the consignment during transit, namely:-


