Sealed tender in plain paper are invited by the undersigned from intending bidders for auction sale of vehicle (**Trekker**) bearing Registration No-OR-15-5109 on "as the where basis". The upset price of the vehicle has been fixed at ₹ 20,000/- (Rupees <sup>twenty</sup>~~forty~~ thousand ) only. The intending bidders may inspect the vehicle in the office campus of the undersigned located at Kachery Road, In front of SBI Main Branch, Sambalpur on any working day during the Office hours from 11 A.M. to 5 P.M. before dt. 24.07.2019. The intending bidders may submit their sealed tenders which should accompany earnest money deposit of ₹. 5,000/- (Rupees five thousand ) only in shape of Bank Draft payable at SBI, Main Branch, Sambalpur in favour of the Addl. Commissioner of CT & GST, Territorial Range, Sambalpur. The earnest money of the unsuccessful bidder shall be returned to them immediately after the acceptance of higher offer. **The last date of receipt of sealed tender is fixed on dt. 25.07.2019** by 4 P.M. and the tenders so received shall be opened on dt.29.07.2019 at 11 A.M. in presence of the bidder if any. The highest bidder whose tender will be accepted shall have to deposit 25 % of the tendered amount by dt.02.08.2019 and the balance by 06.08.2019. In case the bidder fails to make the deposit in full as per the terms of the notice within the stipulated time the deposit already made along with the EMD shall be forfeited. The amount deposited in shape of EMD and at the time of acceptance of the tender shall have to remove the vehicle within seven days from the date of deposit of the full amount quoted at his own cost. On failure to remove the vehicle within the stipulated time shall attract payment of ground rent @ 1 % of tender amount per day till removal of the vehicle from the campus. If the ground rent so charged shall exceed the sale price deposited the bidder shall cease to have any right over the vehicle and the amount deposited shall be adjusted towards ground rent.
