AUCTION SALE NOTICE

Sealed tenders in plain papers are invited by the undersigned from intending bidders for purchase of condemned Govt. Vehicle bearing No. OR-05-H-1400(TATA SUMO DLX) of TATA make of CT & GST Circle, Bhubaneswar IV, Bhubaneswar.

The intending bidders can inspect the vehicle in the office premises of the undersigned located at Sukavihar, CT & GST Building, near Saheed Nagar Police Station, PO- Bhoi Nagar, Bhubaneswar, PIN-751022 prior to submission of tender paper by then in any working day during office hour.

The bidders shall furnish earnest money deposit of Rs.1000/- (Rupees one thousand) only in shape of Bank Draft in favour of The Deputy Commissioner of CT & GST, Bhubaneswar IV, Bhubaneswar which will be refunded to the unsuccessful bidders after finalization of the bids. The EMD furnished by the highest bidder will be adjusted against sale price of the vehicle.

The last date of receiving sealed tender/auction sale in the CT & GST Circle, Bhubaneswar IV, Bhubaneswar is on dt **17/05/2019 till 11.00 A.M.** at the latest and tenders so received shall be opened by the tender committee on the same date i.e. **on 17/05/2019 at 4.00 P.M.** in presence of the available bidders or their authorized representatives. The bidders shall produce their identity proof on the scheduled date and time before opening of tenders. The bidders should subscribe the words "Offer for auction sale of condemned Govt. Vehicle with the details present address & mobile No." on the sealed cover. The amount offered by the bidders should be written clearly in words & figures. Any deviation in Tender and stating of facts and figures make them liable for rejection of Tender. For the purpose of receiving the Tenders, a sealed box will be kept at the office chamber of the undersigned.

The highest bidder whose tender would be accepted shall deposit immediately 25% of the bid amount as initial deposit. He shall deposit the balance amount within seven days of the deposit of the initial amount and remove the vehicle with permission of the undersigned. In case he/she fails to make the deposit of the total amount as per the tender within the stipulated time his initial deposit including the earnest money shall be forfeited. GST as admissible shall be levied on the bidding cost. The auction purchaser shall be solely responsible for payment of GST.

In case the bidder whose tender could be accepted fails to remove the vehicle from the office campus within stipulated time he/she shall pay ground rent @1% of his quoted price per day. If the ground rent so charged exceeds the amount deposited by the highest bidder then the bidder shall cease to have any right on the vehicle and the amount deposited by the bidder shall be adjusted towards ground rent & the vehicle shall become absolute property of Govt.






