

 - b) Years of Experience in implementing/ executing assignments related to the field of supplying Manpower like Peons & Watchman Cum Sweepers for any Govt. /Private Organizations.
 - c) Work experiences showing competency in implementing/executing assignments related to above fields for any Govt. / Private Organizations.
 - d) Availability of 'House Keeping' for keeping Office neat & clean, assigned Official duties and also to guard Office.
