

NOTIFICATION

In exercise of powers conferred by Section 168 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017) read with sub-rule (5) of 61 of the Odisha Goods and Services Tax Rules, 2017, I, Saswat Mishra, IAS, Commissioner of State Tax, on the recommendations of the Council, do hereby make the following further amendments-

- (i) in notification No.12250/CT, dated the 8th August, 2017; and
- (ii) in the notification No.16673/CT, dated the 15th November, 2017, namely:-
