**NOTIFICATION**

In exercise of powers conferred by Section 168 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017) read with sub-rule (5) of 61 of the Odisha Goods and Services Tax Rules, 2017, I, Saswat Mishra, IAS, Commissioner of State Tax, on the recommendations of the Council, do hereby make the following further amendments-

- (i) in notification No.14031/CT, dated the 16<sup>th</sup> September, 2017; and
- (ii) in the notification No.4724/CT, dated the 22<sup>nd</sup> March, 2018, namely:-

In the said notifications, in the first paragraph, in the proviso, for words, figures and letters "July, 2017 to November, 2018" and "31<sup>st</sup> day of December, 2018", in words, figures and letters "July, 2017 to February, 2019" and "31<sup>st</sup> day of March, 2019" shall be respectively substituted.
