

**NOTIFICATION**

In exercise of the powers conferred by sub-section (3) of section 5 of the Odisha Goods and Services Tax Act, 2017, I, Sanjay Kumar Singh, IAS, Commissioner of State Tax, do hereby delegate the powers under section of this Act mentioned in column (2) and rules framed there under and described in column (3) to the officers specified in column (4) of the table below, subject to the condition that the powers so delegated shall be performed only within their respective jurisdictions.






